### **FARM DOG CERTIFICATION TEST OPEN TO ALL BREEDS.**

The AKC Farm Dog Certified (FDC) Test is open to all dogs at least 9 months of age that are individually registered with the AKC, recorded in the FSS program, dogs with PAL numbers, or neutered dogs enrolled in the AKC Canine Partners program. Females in season may not participate. Dogs with physical c eligible to enter provided, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the entire course.

**To earn your AKC Farm Dog Certification Title**, you must Qualify under two different Judges. There are two different judges on Saturday and Sunday, 2 trials per day, 4 total over weekend

An application form for the title can be found on AKC website. They will be available at check in desk for your convenience. Owners will need to complete the application form and send it and the appropriate fee to the American Kennel Club.

**PRIZES:** Qualifying Ribbons will be given to those that “Pass”

**AGREEMENT (MUST be included with entry form)**

I, (we) acknowledge that the “rules Applying to Registration and Dog Shows” and the “rules for Herding Tests & Trials” have been made available to me (us) and that I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. I (we) will pay for any injuries or the replacement value in this event of serious injury to the livestock caused by my (our) dog. I (we) agree that the determination of whether the injury is serious shall be made by the event veterinarian and is binding on me (us). Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons.

**From West:** Okeechobee Road east and turn right onto Peacock Rd. If you pass under a pedestrian overpass, you have gone too far.

**From I-95:** Take exit # 129 (Okeechobee Rd.) go west 6.5 miles. The Fairgrounds are on your left. Just past a pedestrian overpass, turn left on Peacock Rd. and enter the Fairgrounds on your left.

**From the FL Turnpike:** Take exit # 152 (Okeechobee Rd.) go west 6 miles. The Fairgrounds are on your left. Just past a pedestrian overpass, turn left onto Peacock Rd and enter the Fairgrounds on your left.
